Collaboration

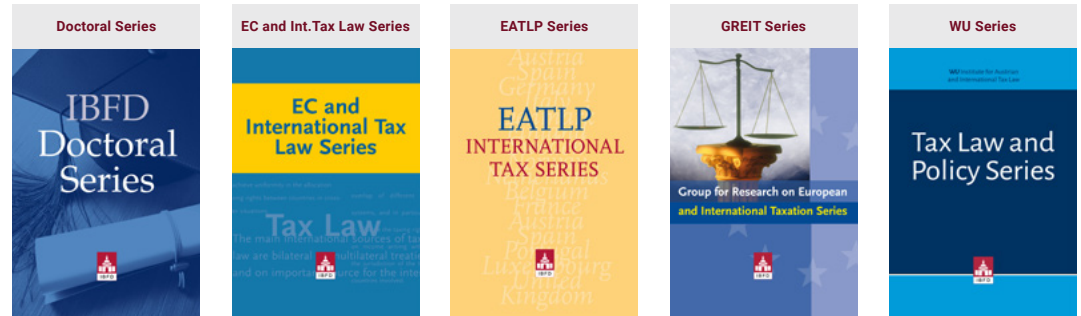
